Most public performances of a video in a public room (including library meeting rooms), whether or not a fee is charged, are an infringement of copyright. Such performances require a public performance license from the rights holder. There are few exceptions to this rule unless the public performance is determined to be a fair use.

Six Rights of Copyright: Part IV - The Right to Public Display

A “public performance” of music is defined in the U.S. copyright law to include any music played outside a normal circle of friends and family. Songwriters, composers, and music publishers have the exclusive right to play their music publicly and to authorize others to do so under the copyright law. This is known as the “Performing Right”. This right was designed to enable and encourage music creators to continue to create music.

Copyright And Public Performance Of Music

Performers’ rights last for a period of 50 years, from the end of the year in which the performance takes place. However, if during that period a recording of the performance is released to the public, the duration of rights will be extended for another 50 years calculated from the end of the year in which the recorded performance is released.
