Set Aside Final Judgements Alllegaldocuments Rule 1.540(b), Florida Rules of Civil Procedure provides that a Final Judgment may be set aside for mistakes, inadvertence, excusable neglect, newly discovered evidence, fraud, etc. However, the rule also states that the motion shall be filed within a reasonable time, and not more than 1 year after the judgment, decree, order, or proceeding was entered or taken.
